### 4. FIRST AID MEASURES

**Aspiration pneumonia hazard:** • May be fatal if swallowed and enters airways

**Description of first aid measures:**

<b>Eye contact:</b>	Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.
<b>Skin Contact:</b>	Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.
<b>Ingestion:</b>	If swallowed, IMMEDIATELY call a poison control center or doctor for treatment advice. DO NOT give <b>any</b> liquid to the person. Do not induce vomiting unless told to do so by a poison control center or a doctor. Never give anything by mouth to an unconscious person.
<b>Inhalation:</b>	Remove affected person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.
